SPEAKER BIOS



JD FLYNN is a journalist, a canon lawyer, and the founder of The Pillar, a media project focused on public accountability reporting on the life of the Catholic Church. JD is also an adjunct professor of canon law at St. Patrick's Seminary in Menlo Park, California, and has served professionally in diocesan administration and as a consultant to the USCCB.

JD's writing has been published in the Wall Street Journal, the Washington Post, the New York Post, and other publications. He is a board member of the FIRE Foundation, which enables the inclusion of children with disabilities in Catholic schools, and in 2018, he was appointed Admiral in the Great Navy of the State of Nebraska.

SR. MARY GRACE, S.V., grew up on the shores of Sydney, Australia, and graduated from the University of Notre Dame Australia with a degree in Theology. Captivated by the beauty of each human life and feeling compelled to lay down her life to protect it, she worked for the campus ministry team before entering the Sisters of Life in 2013. Sister Mary Grace made her first vows in 2018, and served in Toronto, Canada, serving vulnerable pregnant women and their unborn children, inviting those wounded by abortion into the healing mercy of Jesus, and offering retreats. She currently resides at St. Frances de Chantal Convent in the Bronx, New York, serving as the Coordinator of the Evangelization Mission. This mission is entrusted with sharing the charism of life and fostering a culture of life throughout the US and worldwide.





Ethics and Public Policy Center Fellow **ERIKA BACHIOCHI** is a legal scholar specializing in Equal Protection jurisprudence, feminist legal theory, Catholic social teaching, and sexual ethics. A 2018 visiting scholar at Harvard Law School, she is also a Senior Fellow at the Abigail Adams Institute in Cambridge, MA, where she founded and directs the Wollstonecraft Project. Her newest book, The Rights of Women, Reclaiming a Lost Vision, was published by Notre Dame University Press in 2021, and was named a finalist for the Intercollegiate Studies Institute's 2022 Conservative Book of the Year Award.

Ms. Bachiochi's essays have appears in publications such as the Harvard Journal of Law and Public Policy, Christian Bioethics (Oxford University), The New York Times, The Atlantic, First Things, CNN.com, National Review Online, National Affairs, Claremont Review of Books, SCOTUSblog, and Public Discourse. She is the editor of two books, Women, Sex & the Church: A Case for Catholic Teaching (Pauline Books & Media, 2010) and The Cost of "Choice": Women Evaluate the Impact of Abortion (Encounter Books, 2004).

BERNADETTE TASY serves as a Media Relations Manager at Alliance Defending Freedom, focusing on issues concerning the sanctity of life and religious freedom. Originally from Reedley, CA, she previously worked on numerous pro-life efforts at the local, state, and national levels. In 2017, with the help of ADF, Bernadette took legal action against a Fresno State professor for leading a group of students in defacing her student group's university-approved, pro-life chalk messages. She and her group won the lawsuit, helping to intensify her passion for the pro-life movement.

Bernadette has had her work published at The Federalist, Townhall, The Daily Signal and other outlets and is a former Campus Reform correspondent, appearing on Fox News and other national media. She graduated summa cum laude from Fresno State in 2017 with a Bachelor of Arts in Communicative Disorders and Deaf Studies and summa cum laude in 2019 with a Master of Arts in Speech Language Pathology. Bernadette was a piano instructor, choral accompanist, and full-time speech language pathologist before joining the ADF team to defend pro-faith, pro-family, and pro-life values.

KAT TALALAS is Assistant Director for Pro-Life Communications at the US Conference of Catholic Bishops. Previously, she has worked in law in New Jersey, as a journalist in Washington DC, and as a legislative assistant in Congress. More recently, she has served as a program coordinator and media trainer for a women's pro-life nonprofit. She graduated with high honors from Rutgers University with a BA in English and received her JD from the College of William and Mary School of Law. Her writing has appeared in a variety of secular and non-secular publications. She joined the USCCB in 2018.





DENNIS KELLOGG serves as the Director of Communications for the Catholic Diocese of Lincoln. He oversees internal and external communications for the diocese. The Office of Communications produces the Southern Nebraska Register, the weekly newspaper of the diocese, as well as all social media channels for the diocese including ones on Facebook, Instagram, Twitter and YouTube. Dennis also serves as a resource for parishes and schools across the diocese on communication matters.

Before joining the Lincoln Diocese in July of 2022, Dennis worked for 35 years in broadcast journalism, most recently as news director of Nebraska Public Media. Dennis has a master's degree from Syracuse University and an undergraduate degree from the University of Dayton. He has served as president of the Nebraska Associated Press Broadcasters Association, president of the board of directors of the Midwest Broadcast Journalists Association and as Nebraska state coordinator for the Radio Television Digital News Association (RTDNA). He also served on a national committee that produced a journalism standards and practices handbook for NPR stations across the country.

Dennis and his wife Jennifer are members of St. Peter Parish in Lincoln. They have three adult children and seven grandchildren.

Maria has taught college classes in human rights, international relations, and public policy. She is known for providing students with the tools to have civil and respectful conversations around controversial topics. Maria previously served as a missionary for the Fellowship of Catholic University Students (FOCUS), followed by a couple years as a high school youth minister at Pius X High School in Lincoln, NE. She and her husband, Mitch, have three children: Gemma (10), Gerard (7) and Morgan Frances (their baby saint in Heaven). She loves the Eucharist, spending time with her family, coffee with friends and traveling. Maria has a heart for advocating for the inherent dignity of every human person from conception to natural death and bridging the political divide with Our Lord at the center.





MARION MINER is the Associate Director of Pro-Life & Family Policy at the Nebraska Catholic Conference.
