# A POST-ROE, PRO-LIFE NEBRASKA

#### **BUILDING A THRIVING CULTURE OF LIFE**



Nearly 50 years ago, the U.S. Supreme Court revoked the states' ability to protect all human life with the decision of Roe v. Wade. Since 1973, abortion has taken over 60 million preborn lives in the United States and has victimized a similar number of post-abortive women and men.



In 2020, a Mississippi law protecting preborn life at 15 weeks was challenged in the historic Supreme Court case, Dobbs v. Jackson Women's Health Organization. In Dobbs, the Court was presented with the opportunity to uphold Mississippi's 15-week ban on abortion, and to overturn Roe v. Wade and Planned Parenthood v. Casey, the two cases whose precedent has protected a so-called 'right to abortion'.



Catholic Social Teaching informs us that every human life is sacred, from the moment of our creation at conception to natural death. As we are all made in the image and likeness of God, every life, born and preborn, is worthy of protection. The Church is uniquely responsible for fighting for the right to life, and for supporting vulnerable women, men, and families in difficult circumstances.



The U.S. Supreme Court has finally overruled Roe v. Wade and Casey v. Planned Parenthood! After 50 years of prayer, education, and social and political action, states can once again protect all preborn human life, and further provide support to abortion-vulnerable women and men. Our work to build a thriving culture of life is beginning anew. Now is the time for all pro-life allies to become stronger advocates for the culture of life.

Email and call your Nebraska State Senator AND your federal representatives. Ask for regulations that make Nebraska abortion-free by protecting all human life from conception. Though Roe has been overturned, abortion is still legal in Nebraska until 20 weeks post-fertilization.
